

MFTransparency promotes transparent pricing and consumer protection in microfinance markets internationally. We do this by collecting and publishing data on prices of microloans, developing and disseminating educational materials and providing in-country training for stakeholders of local microfinance markets. We have also advocated for transparent pricing as speakers at more than 20 industry-wide events. In less than two years of operations we have completed projects in 6 countries with another 7 underway and 16 more in the pipeline. We currently have pricing data published on our website for Azerbaijan, Bosnia, Cambodia and Kenya, representing more than 56 institutions and 270 loan products sold to more than 3 million clients. Currently we have projects underway in India, Bolivia, Ecuador, Colombia, Burkina Faso, Senegal and Malawi. Nearly 100 leading industry experts from around the world participated in our first data launch webinars, and more than 500 industry participants have expressed support for our work by signing our endorsement statement.
